

Mobile Device Testing Process

Units arrive at our secure facility and are individually asset tagged. We record the make, model, IMEI number and/or serial numbers along with an initial condition grading via visual inspection.

Once all devices have been through our rigorous testing process, we will issue each client with a detailed asset report with our testing results and rebates that we can offer per device. Data erasure documents for each device will be provided as standard procedure stating all personal and sensitive information has been destroyed with our approved software. We do offer non-working rebates for mobile phones and tablets providing we can data erase such devices and that these damaged devices have a resale value. Any device which we cannot data erase we will granulate and issue data destruction documents for peace of mind that your personal information has been securely destroyed.

Performance Stress Testing

We rigorously test the performance of all data sanitised assets. We use a program that subjects the hardware and components to high workloads and heavy data traffic to identify any issues.


